# (Devkiba Law - Common Entrance Test)

Smt. Devkiba Mohansinhji Chauhan College of Law will be conducting DL-CET in order to shortlist aspirants for admission in both 5 years integrated B.L.S.LL.B. and 3 years LL.B. course. The candidates who are desirous to take admission in Law courses offered by our college, will be required to appear for DL-CET.

#### B.L.S.LL.B. (5 Year Course)

The five year B.L.S.LL.B. degree is a 10 semester full time integrated course. Performance of each student shall be evaluated by the examinations conducted at the end of each semester and also the performance in the Practical Training Subject as per the guidelines issued from time to time by the Bar Council of India and University of Mumbai.

# **Eligibility:**

- Minimum 45% in 1<sup>st</sup> attempt at HSC (any stream) from a recognized board.
- 5% relaxation to SC. ST candidates.
- The candidates who have appeared for HSC examination and whose results are awaited are eligible for DL-CET subject to clearing the exam with 45% in 1<sup>st</sup> attempt.

# LL.B. (3 Year Course)

Bachelor of Laws and Legislation is a three year Degree course. The teaching is conducted through the lecture method and practical training throughout the semesters. Performance of the students is evaluated through written examinations and viva voce as per the guidelines issued by Bar Council of India and University of Mumbai from time to time.

# **Eligibility:**

- Minimum 45% at graduation level (any stream) in 1<sup>st</sup> attempt from UGC recognized university.
- 5% relaxation to SC, ST candidates.
- The candidates who have appeared for the final year exam of graduation and whose results are awaited are eligible for DL-CET subject to clearing the exam with 45% in 1st attempt.
